Purpose of the post

To be responsible for carrying out the duties set out in the Teachers Pay and Conditions Document, as directed by the Head of School

1. CONSULTATION

In carrying out these duties, to consult, where appropriate, with the relevant senior manager, the staff in school, parents and carers, pupils and the wider community.

2. IN RELATION TO THE STATUTORY REQUIREMENTS

The appointment is subject to the current conditions of employment for Class Teachers contained in the School Teachers' Pay and Conditions Document, the 1998 School Standards and Framework Act, the required standards for Qualified Teacher Status and Class Teachers and other current legislation.

3. AREAS OF RESPONSIBILITY AND KEY TASKS

A PLANNING, TEACHING AND CLASS MANAGEMENT:

Teach allocated pupils by planning their teaching to achieve progression of learning through: • identifying clear teaching objectives and specifying how they will be taught and assessed • setting tasks which challenge pupils and ensure high levels of interest and participation • setting appropriate and demanding expectations

with a clear appreciation for national expectations by the end of EYFS

- setting clear targets, building on prior attainment, and communicating clearly with pupils, support staff, other teachers in the setting and parents
- identifying vulnerable pupil groups (SEN, EAL, FSM, HA pupils) and taking a pro-active approach to ensure accelerated progress;
- provide clear structures for lessons maintaining pace, motivation and challenge; make effective use of assessment and ensure coverage of programmes of study; ensure effective teaching and best use of available time;
- monitor and develop effective intervention to ensure good learning and pupil progress use a variety of teaching methods to:
 - i. match approach to content, structure information, present a set of key ideas and use appropriate vocabulary
- ii. use effective questioning, listen carefully to pupils, give attention to errors and misconceptions iii. select appropriate learning resources and develop study skills through books, visual props, audio visual clips I.C.T. and other sources;
 - ensure pupils acquire and consolidate knowledge, skills and understanding appropriate to the subject taught;
 - evaluate their own teaching critically to improve effectiveness and respond positively to lesson observation feedback and suggestions for further development;
 - encourage pupils to think and talk about their learning, develop self-control and independence, concentrate and persevere, and listen attentively;
 - use a variety of teaching strategies which involve planned adult intervention, first-hand experience and play and talk as a vehicle for learning;
 - make effective use of additional adults in the classroom to support learning.

B MONITORING, ASSESSMENT, RECORDING, REPORTING:

- assess how well learning objectives have been achieved and use formative assessment to tailor specific aspects of teaching to secure learning;
- mark and monitor pupils' work daily and set and communicate targets for progress; assess and record pupils' progress systematically and keep records to check work is understood and completed, monitor strengths and weaknesses, inform planning and recognise the level at which the pupil is achieving;
- prepare and present informative reports to parents.

- have a working knowledge of teachers' professional duties and legal liabilities;
- operate at all times within the stated policies and practices of the school;
- establish effective working relationships and set a good example through their presentation and personal and professional conduct;
