Main Accountabilities

Curriculum

- 1. To contribute to Schemes of Work and curriculum materials for the age of pupils taught.
- 2. To plan effective lessons, matching the design of the lesson to the ability of the pupils and the Academy curriculum.
- 3. Have high expectations of pupils based on a sound knowledge of each of their needs.
- 4. To take account of the need for progression in pupils' learning experiences.
- 5. To ensure effective whole class, group or individual learning opportunities for pupils.
- 6. To set high standards of expectations for pupils' behaviour through good classroom discipline, focused teaching and productive relationships.
- 7. To set and assess homework as an integral part of pupils learning.
- 8. To use opportunities to reinforce literacy, ICT and numeracy skills within teaching.
- 9. To use enterprising and innovative approaches to teaching and learning when appropriate and in accord with subject and Academy policy.
- 10. To deliver the lesson programme effectively.
- 11. To contribute to the extra-curricular activities programme for pupils.


