#### **JOB DESCRIPTION**

# FOOD/DESIGN TECHNOLOGY TECHNICIAN

- 1 To maintain Food Technology to the Design & Technology Department.
- 2 To help ensure practical environments are safe, clean and tidy
- To prepare materials for Food lessons, as requested by each member department, using the appropriate equipment. This will include keeping the food pantry in order and assisting with the cleanliness of sinks, cookers and units.
- 4 To manage stock electronically, keeping and ordering all departmental materials and equipment, whilst maintaining a record of departmental spending.
- 5 To ensure all equipment is stored securely after use.
- To ensure all students' work and unused materials is returned to the appropriate storage area.
- 7 To support the department in managing resources and displays in other DT areas such as Graphics, Textiles and Product Design.
- To help produce teaching aids and update displays and visual material around the department. This includes assisting with preparation and setting up displays, for events in other areas of the school.
- 9 To maintaining H&S records, including Equipment checks, Risk Assessment, COSHH, LEV and site audits.
- To develop the infrastructure of facilities of the department as required, including producing bids for new machinery or equipment.
- 11 To assist with organisation of trips

- To be a pro-active member of the department team and, as such, work within that team on developments and projects as required, enhance career and professional development and departmental development.
- To provide written reports for internal use and external use as required by the school
