## **JOB OVERVIEW**

We are seeking a dedicated and experienced Level 3 Qualified Practitioner to join our nursery team at Braywick. This role is a maternity cover, and due to staffing needs, the successful candidate will also be required to take on managerial responsibilities and support the team during this period.

Working closely with staff, parents, and external stakeholders, you will ensure high-quality childcare and education for children in the nursery, promoting a safe, stimulating, and nurturing environment.

#### Areas of Responsibility and Key Tasks

#### Strategic Direction and Leadership

- Support the temporary leadership of the nursery in the absence of both the Nursery Manager and Deputy Manager.
- Contribute to the development and implementation of nursery policies and procedures, ensuring alignment with the broader goals of the Multi-Academy Trust (MAT).
- Lead by example to foster a culture of excellence, inclusion, and professionalism within the team.

#### **Teaching and Learning**

- Plan and deliver a stimulating and developmentally appropriate curriculum for children aged 2-5.
- Observe, monitor, and assess children's progress, ensuring records are kept up-to-date and parents are informed of their child's development.
- Support the team in implementing best practices for early years education, ensuring compliance with the Early Years Foundation Stage (EYFS) framework.
