NAME:

POST: Catering Assistant

GRADE: 2 SCP 2 - 4

RELATIONSHIPS:

The post holder is accountable to the Catering Manager in all matters relating to this post. All staff are ultimately responsible to the Chief Executive Officer (CEO). The post holder will work closely with team members and support the team when necessary.

PURPOSE:

Main duties to help prepare, cook and serve lunch. Responsible for cleanliness of equipment and working area.

MAIN DUTIES & RESPONSIBILITIES:

- To maintain high standard of personal appearance, behaviour and hygiene.
- To maintain high standard of kitchen hygiene.
- To have knowledge of the menu in advance.
- To report any damage or mechanical faults in equipment to the Catering Manager.
- To maintain a good relationship between kitchen staff.
- To set up servery for lunch, filling water jugs, correct condiments.
- To help with food preparation.
- To assist with general cleaning of surfaces, floors, walls and equipment.
- To support in service of meals.
- To assist with preparation of sandwiches and light snacks for Meetings/Parents Evenings.
- To assist with preparation of packed lunches for school trips.
- To assist with dining-room washing-up.
- To drive minibus and deliver meals to AAT academies as identified.

GENERAL:

- To promote and support AAT's culture of "High Expectations for All" and encourage staff and pupils to follow this example.
- To promote and safeguard the welfare of pupils in your care or that you come into contact with in accordance with the Trust Child Protection and Safeguarding Policy.
- To comply with, promote and act in accordance with all Trust and Academy policies.
- To be responsible for complying with data protection legislation and expectations for confidentiality. Any issues or breaches to be reported to the Trust HR Director at the earliest opportunity.

- To maintain consistent working relationship with colleagues, supporting them in line with your role and responsibilities.

- To develop your effectiveness by up-dating your knowledge and skills, seeking and taking account of constructive feedback on your performance, making effective use of the development opportunities made available to you.
- To identify and agree personal development objectives with your line manager.
- To be courteous to colleagues and provide a welcoming environment to visitors.
